

# KPro4 Upgrade Form



## Overview

This upgrade replaces the green or red board KPro with a new Bluetooth equipped circuit board. The replacement circuit board has a one-year warranty.

KPros or ECUs without serial numbers cannot be processed.

If Hondata finds that your old KPro is functionally damaged, you will have the option of: (1) Paying an additional \$100 for the upgrade; (2) Getting the ECU sent back to you in its as-is condition (Shipping fees: \$40 California, \$50 Out of State and/or \$100 International).

## Please send the following items to Hondata:

- ECU with KPro (both must be in working order, key and immobilizer not needed)
- Both pages of the form, signed and dated on the last page
