## Overview

This procedure applies only to S2000 ECU's that are 2006+ or later that are using FlashPro. We will add the components necessary to enable EGRL input on pin B12 for wideband input.

## Please send the following items to Hondata:

- ECU & FlashPro – S2000 ECU that is 2006+ or later. Must have serial number. ECUs sent without serial numbers will not be accepted due to the possibility of theft.
- Payment in the form of a **cashier's check or money order**. No personal checks.
- A completed and signed copy of this form.
