## Overview

Hondata is offering an upgrade to a S300 from a S100, S200 or a staged system (must be OBD1). The cost below includes socketing. A reliability upgrade is available (+\$50) which installs 8 high quality replacement capacitors. Turnaround time is 2-3 days.

- ☐ OBD1 ECU – Must be in working condition and must have serial number. ECUs sent without serial numbers will not be accepted due to the possibility of theft.
- ☐ Hondata S100 / S200 / Staged System being traded (must be in fully working condition).
- ☐ Dealer's Purchase Order. **All orders and payments are made through your dealer.**
- ☐ A completed and signed copy of this form.
